





### Access Guide - Solent NHS Trust

The Care and Health Information Exchange (CHIE) is a computer system used by the NHS and Social Care to safely share important information about a patient with those treating them. You can use CHIE to access GP records, community records and hospital records (pathology reports, X-ray or scan reports, discharge summaries and clinic letters) for patients registered to practices in Hampshire and the Isle of Wight.

## **Accessing CHIE through Solent SystmOne:**

Solent NHS Trust staff can access CHIE directly from SystmOne

**IMPORTANT:** In this new upgrade – all clinical/admin information recorded in the 'springboards/clinical templates' by the services will be uploaded to CHIE as soon as the patient record is saved in SystmOne. This will include all free text information recorded in the templates for the patient.

Some SystmOne units have been deemed as 'sensitive' and not 'relevant for patient care' by Information Governance and hence will not be able to feed this information into CHIE. However, they will be able to access all clinical information recorded by other organisations involved in patient care through CHIE.




• With a patient record open in SystmOne, click on the CHIE(HHR) link on the toolbar on the top right of the screen to the left of the patient demographic box




 Please read the CHIE Acceptable Usage Agreement displayed on the screen and click on the Red C button on the bottom of the screen to access CHIE.



• If you are accessing CHIE for the very first time you will receive the below disclaimer that you will be asked to read and accept. Please ensure you read and accept this screen.



 Once accepted, you will access the CHIE record for the selected patient, also called the 'landing page/Patient home page'
