



### Access Guide - Emergency and OOH (inc. SCAS and PHL) (via Adastra & or iCAD)

The Care and Health Information Exchange (CHIE) is a computer system used by the NHS and Social Care to safely share important information about a patient with those treating them.

You can use CHIE to access GP records, Community and Mental Health, Social Care, and hospital records (pathology reports, X-ray or scan reports, discharge summaries and clinic letters) for patients registered to GPs in Hampshire and the Isle of Wight.


